RESERVATION AND PAYMENTS

Attached to this Agreement is your Reservation Form and Itinerary. We will confirm the reservation within 7 days after receiving the Reservation Form. If a charter flight is included and fully booked, we will advise you of alternate travel dates. All land arrangements, hotel nights, meals, transfers, sightseeing etc. (if applicable as per reservation form and itinerary) must be paid when the reservation is confirmed. Flight tickets will be issued only after the reservation is confirmed, and you must pay the full charter price when the ticket is issued. All checks, money orders, and credit card drafts must be made payable to your travel agent and/or AmericanTours International.

VISA INFORMATION*

All travelers must have a valid passport and a Cuban visa. You are responsible for having proper documentation on your person to enter Cuba as well as to re-enter the United States and proper documentation to travel via a third country (if necessary) to Cuba. For certain categories of travel ATI can issue a Cuban visa. The Cuban Government retains the right to grant or deny visas. We are not able to issue Press or Religious or Academic Visas.

***Very Important: persons born in Cuba, no matter what your current citizenship, will require additional documentation. Please contact our office for further information.**

CANCELLATIONS AND REFUND POLICY

If you cancel your reservation, or if you fail to travel on any component of your outlined itinerary or flight, your right to receive a refund is limited. Please refer to the detailed terms and conditions on the CubaATI website and the information received when your individual reservation is confirmed. All requests for refunds must be emailed or faxed to AmericanTours International, LLC. Refunds where applicable will be made within 14 days of receipt of your notice of cancellation.

INTERNATIONAL FLIGHTS

The operation of the charter flight is subject to the Cuban government granting landing rights. If the air carrier cannot obtain landing rights, the flight will be cancelled, and a full refund will be made to you automatically.

BAGGAGE

The air carrier allows each passenger to check up to 44 pounds of baggage. Charges for excess baggage over 44 lbs. will be collected at the airport. For INTERNATIONAL flights, the air carrier's liability for lost or damaged bags is limited to the actual value of the baggage, but not more than amounts set forth in the Montreal Convention. Specifically, the air carrier's liability is limited to 1,331 Special Drawing Rights regardless of the number of checked bags. If, however, you declare a higher value for your baggage and pay an additional charge in advance, the air carrier's liability will be higher. You must submit your claim for lost or damaged baggage to the air carrier or to us within 3 days of the charter flight. Your claim must include a copy of the Baggage Check.
